

ZONE ONE AGILITY TEAM TRIALS

NZDAC 2018 - Fielding
Saturday 11th & Sunday 12th of August 2018

VENUE: Cambridge grounds Mc Kinnon Park Taylor St Cambridge
There will be 4 Agility trials for each class run over the 2 days. The best 3 runs count.

RUNNING ORDER: **Saturday:** Intermediate, Starters, Senior, Novice, Intermediate, Starters, Senior,
Novice

Sunday: Novice, Senior, Starters, Intermediate, Novice, Senior, Starters,
Intermediate

COST \$10 per dog per class i.e if trialling for starters and novice a total of \$20.00 will be payable. Cheques to be made out to "CASH".

ENTRIES Must be on an official team event entry form (available on the day) and fees paid on the first day of the trials

Dogs must be 18mths of age on the first day of the trials.
Dogs enter classes that they are eligible for as at 1st June 2018.

N.B – please note that when you sign your entry for you give an undertaking that if selected, you will travel to the NZDAC in Fielding.

ZONE 1 AGILITY TEAM TRIAL RULES (N.Z.D.A.C. INTER-ZONE TEAM COMPETITION)

- 1. TIMING AND NUMBER OF TRIALS.**
 - a. Team Trials must be held between August 1st and August 31st.
 - b. Four Team Trials will be held, separate from any other fixture. These trials will be placed in the Agility calendar at the earliest possible opportunity.
 - c. The trials Manager will provide notification of the trials and relevant details as soon as practical before the trials

- 2. ENTRY.**
 - a. Entry for all Team Trials will only be accepted on the first day of the Team Trials, unless a competitor is absent under rule 3.2 below.
 - b. An entry fee of \$10.00 will be charged per dog per class trialing for in Agility. This covers all trials, and is non-refundable, regardless of number of trials attended.
 - c. All entrants must be financial members of the NZKC.

- 3. ATTENDANCE.**
 - a. Attendance at all of the allocated trials is optional, (keeping in mind entries are only taken on the first day). However; competitor's scores will only be ranked against other competitors who have completed all of the trials.
 - b. Special dispensation may be given by the trials organizers for a competitor to be absent from one trial, and still have their scores counted. Such requests should be in writing.
 - c. Competitors who do not complete all of the trials or obtain dispensation as per 3(b) above, are ineligible for team selection.

4. SCORING.

- a. Scoring will be based on one point per placing (eg 1st = 1 point, 3rd = 3 etc).
- b. Where faults are incurred, these are added to the placing points. (eg 4th on 5 faults = 4 + 5 = 9 points).
- c. Maximum points with faults will be 25 with a disqualification earning 30 points.
- d. The dog with the least points over 3 out of 4 trials will be deemed the Team Dog. In the event of a tie, the 4th run points will be added in and the dog with the least points will be deemed the team dog.

5. TEAM MEMBER REQUIREMENTS.

- a. Team members are required to travel to the NZDAC and enter the teams event.
- b. Team members are required to wear the team uniform, some of this will be supplied by the Agility Committee and the rest will be supplied by the individual Team member.
- c. All Team members will be required to attend a meeting on the final day of the Trials to decide (in conjunction with the Trials Manager) upon the uniform for all team members.
- d. Team members must complete and sign an official NZKC entry form for the NZDAC team event, and pass this to the Trials Manager as soon as possible after the Trials.

6. BITCHES IN SEASON.

- a. As (under Agility Regulation 1.1) the Zone One Team Trials are a recognized and approved Zone "fixture", then Dog Training regulation 5.4.2 must apply and Bitches in season will not be allowed to attend.

7. SUBSIDY.

- a. The Agility Committee will provide a subsidy to each team member, to assist with travel and uniform expenses.
- b. The subsidy will vary depending on the area that is being travelled to. The Agility Committee will determine the amount to be paid each year.
